Please note: other taxes such as VAT and Council Tax do not qualify. The amount of Income Tax and/or Capital Gains Tax for each tax year (6 April to 5 April) must be at least equal to the amount of tax that all charities or Community Amateur Sports Club (CASC) that you donate to can reclaim from HM Revenue and Customs on your Gift Aid donation(s) in that tax year. If you pay less Income Tax and/or Capital Gains Tax in the current tax year than the amount of Gift Aid claimed on all your donations it is your responsibility to pay any difference. Thank you!
